2021 Swimming POOL RULES AND REGISTRATION

POOL HOURS 9AM TO 9PM

THE LIFEGUARD IS PERMITTED ONE 30 MINUTE BREAK OR TWO 15 MINUTE BREAKS AT THEIR DISCRETION. DURING GUARD BREAK THE POOL WILL BE CLEARED OF ALL SWIMMER'S & BATHERS WHO ARE NOT SUPERVISED.

THE LIFEGUARD IS THE FINAL AUTHORITY IN ANY GIVEN SITUATION.
SAFETY DEVICES ARE NOT PLAY TOYS THEY ARE FOR EMERGENCIES ONLY.

POOL RULES:

- 1. RUNNING AND HORSEPLAY ARE PROHIBITED. CONDUCT MUST NOT INTERFEAR WITH THE ENJOYMENT OR SAFETY OF OTHERS. THIS INCLUDES, BUT IS NOT LIMITED TO EXCESSIVE SPLASHING, CANNON-BALLING, DUNKING, OR OFFENSIVE LANGUAGE, GESTURES ETC.
- 2 LARGE RUBBER RAFTS, BOATS, INNERTUBES ARE NOT ALLOWED IN THE POOL
- 3. USE BY ANYONE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS IS PROHIBITED.
- 4. CHILDREN 12 OR OLDER, WHO RESIDE IN WOODLAKE, DO NOT NEED TO BE ACCOMPANIED BY AN ADULT WHEN THE LIFEGUARD IS ON DUTY.
- 5. CHILDREN 14 OR YOUNGER MUST BE ACCOMPANIED BY A PARENT OR GUARDIAN 18 YEARS OR OLDER, WHEN THE LIFEGUARD IS NOT ONDUTY.
- 6. PERSONS 13-17 YEARS SHALL NOT SWIM ALONE.

- 7. NO MORE THAN 30 PEOPLE MAY BE IN THE POOL AT A TIME.
- 8. SWIMMING ATTIRE ONLY ALLOWED IN THE POOL. NO CUT-OFFS, RUNNING SHORTS, ETC.
- 10. SWIMMING AIDS ARE TO BE USED IN THE SHALLOW END ONLY. NON-SWIMMING CHILDREN UNDER THE AGE of 5 SHALL NOT BE IN THE POOL WITHOUT A PARENT OR GUARDIAN IMMEDIATELY PRESENT IN THE WATER.
- 11. A SWIMMING TEST WILL BE GIVEN BY THE LIFEGUARD BEFORE CHILDREN ARE ALLOWED TO SWIM IN THE DEEP END OF THE POOL.

12. **NO DIVING**

HEALTH:

- 1. A CLEANSING SHOWER, TAKEN IN THE POOLHOUSE, IS REQUIRED BEFORE POOL ENTRY.
- 2. USE BY ANYONE WITH A COMMUNICABLE DISEASE IS PROHIBITED.
- 3. USE BY ANYONE WHOM HAS-BEEN ILL WITH VOMITING OR DIARRHEA WITHING THE LAST 2 WEEKS IS PROHIBITED.
- 4. CHILDREN WHO ARE NOT POTTY TRAINED MUST WEAR TIGHT FITTING PROTECTIVE COVERINGS.
- 5. ANYONE WITH SEIZURE, HEART, OR CIRCULATORY PROBLEMS SHOULD SWIM WITH A BUDDY.

GENERAL RULES:

ACCESS & USE OF THE POOL IS FOR THE HOMEOWNERS AND RESIDENTS OF WOOOLAKE IN GOOD STANDING WITH THE WOOLAKE HOA.

- 1. POOL GATE AND BATH HOUSE WILL ALWAYS BE LOCKED. MAKE SURE TO SECURE GATE BEHIND YOU. ENSURE BATHROOM DOORS REMAIN LOCKED BEFORE LEAVING THE POOL.
- ONE KEY IS GIVEN TO EACH HOMEOWNER. REPLACEMENT KEY COST IS \$50.
- 3. BEVERAGES (NON-ALCOHOLIC) ARE ALLOWED IN POOL DECK AREA IN NON-GLASS CONTAINERS. EMPTY Containers MUST BE-DISPOSED-Of PROPPERLY. FOOD ITEMS ARE ALLOWED ON THE GRASS AREA ONLY. LIFEGUARD FOOD ITEMS ARE EXEMPT
- 4. POOL FURNITURE IS NOT ALLOWED TO BE PLACED IN NARROW DECK AREAS PER COUNTY CODE. SEE POSTED CHECKERBOARD SIGNS FOR SPECIFIC AREAS AFFECTED.
- 5. POSESSION AND USE OF DRUGS, ALCOHOL, VAPE, & SMOKING IS Prohibited WITHIN ENTIRE AREA OF THE POOL FACILITY (POOL, DECK, GRASS, POOLHOUSE).
- 6. PETS ARE NOT ALLOWED AT THE POOL FACILITY NOR WITHIN THE POOL FENCED AREA INCLUDING THE POOL, DECK, GRASS, AND POOLHOUSE.
- 7. iPod, MEDIA PLAYERS, RADIOS & ALIKE ARE ALLOWED AT THE POOL ONLY IF EARBUDS ARE USED.
- 8. BIKES, SKATEBOARDS, SCOOTERS, HOVERBOARDS, ROLERBLADES ROLLERSKATES ARE NOT ALLOWED IN THE POOL AREA. BIKES SHOULD NOT BLOCK THE PATH OR POOL ENTRANCE.
- 9. IT IS MANDITORY FOR HOMEOWNERS TO REVIEW THE POOL RULES EACH YEAR. A SIGNED REGISTRATION, ATTATCHED, MUST BE COMPLETED AND RETURNED TO THE LIFEGUARD OR POOL MANAGER PRIOR TO USING THE POOL.
- 10. ANY RESIDENT OF WOODLAKE OR THE LIFEGUARD HAS THE AUTHORITY TO REMOVE FROM THE POOL AREA ANY PERSON, REGARDLESS OF AGE, BECAUSE OF UNACCEPTABLE BEHAVIOR.
- 11. THE WOODLAKE BOARD OF TRUSTEES RESERVES THE RIGHT TO DENY POOL PRIVILAGES TO ANY RESIDENT WHO CONTINUES TO

VIOLATE THE RULES OR IS NOT IN GOOD STANDING WITH THE WOODLAKE HOMEOWNERS ASSOCIATION.

GUESTS/RESIDENTS:

- 1. ALL GUESTS MUST BE ACCOMPANED BY THE ADULT HOMEOWNER WHILE AT THE POOL AREA AT ALL TIMES. GUESTS THAT ARE NOT FOLLOWING THE RULES OF CONDUCT POSTED AT THE POOL WILL BE ASKED TO LEAVE, ALONG WITH THE RESIDENT SPONSOR.
- 2. THE **RESIDENTS OF WOOOLAKE HAVE PRIORITY TO USE THE POOL**. IN THE PAST FEW YEARS, THERE HAS BEEN A NOTICEABLE INCREASE IN POOL USAGE & SUBSEQUENT OVERCROWDING DURING PEAK Times.

 THE NUMBER OF GUESTS ARE LIMITED TO FOUR (4) PER HOUSEHOLD. ANYTHING LARGER CAN BE ACCOMODATED BY RESERVING THE POOL
- 3. TRESSPASSING, VANDALISM, AND ILLEGAL BEHAVIOR ARE SUBJECT TO ARREST BY THE UNIVERSITY PLACE POLICE.

FOR A PRIVATE PARTY. (SEE NEXT SECTION FOR DETAILS)

PRIVATE PARTIES:

THE POOL FACILLITY MAY BE RESERVED FOR A PRIVATE PARTY UNDER THE FOLLOWING CONDITIONS:

- 1. THE POOL MAY BE RESERVED FOR TWO HOURS. AFTER THE FIRST HOUR, THE POOL WILL REOPEN FOR ALL RESIDENTS TO USE.
- 2. THE FEE FOR RENTAL IS \$30.00, PAYABLE TO THE WOODLAKE HOA, RENTAL FEES ARE NON- REFUNDABLE. PAYMENT CAN BE SUBMITTED TO THE POOL MANAGER AND IS DUE AT LEAST 7 DAYS BEFORE THE EVENT. DATE AND HOUR OF PARTY WIII BE POSTED ON THE FENCE-GATE & ON THE WOODLAKE WEB SITE AT LEAST TWO DAYS BEFORE THE PARTY.

3. THE POOL MAY NOT BE RESERVED DURING PEAK HOURS (NOON TO 6PM).

HOMEOWNERS AND RESIDENTS RESPONSIBILITIES:

- 1. ALL USERS OF THE POOL NEED TO KNOW/FOLLOW THE RULES OF THIS DOCUMENT, POSTINGS AT THE POOL & LIFEGUARD.
- 2. HOMEOWNERS ARE RESPONSIBLE FOR THE ACTIONS OF THEIR CHILDREN AND GUESTS. EXPLAIN THE RULES TO YOUR GUEST
- 3. HOMEOWNERS ARE FINANCIALLY RESPONSIBLE FOR THE ACTIONS OF THEIR CHILDREN & GUESTS WHILE IN THE POOL AREA.
- 4. PLEASE REPORT ACTS OF VANDALISM AND TRESPASSING TO A BOARD MEMBER AND CALL 911.
